**(4) Other detailed terms and conditions with regard to the appointment, domicile, reservation, etc. are as follows: -**

**(I) Appointment of the candidates**

- (i) The condition of the probation, pay and allowances and fixation of the initial tenure of a person shall be governed as per SKUAST-Statutes together read with S.O. 192 dated 17<sup>th</sup> of June, 2020 (Jammu and Kashmir Probationer (Condition of service, Pay and allowances) and Fixation of Tenure Rules, 2020 issued by Social Welfare Department, UT of J&K and all other future amendments made in the said rule by Govt. of J&K from time to time shall be applicable.

**(II) Domicile**

- (i) The candidate should be a Domicile of the Union Territory of Jammu & Kashmir as defined in terms of the Notifications issued by the Ministry of Home Affairs, Government of India vide S.O 1229 (E) dated 31.03. 2020 and S.O 1245(E) dated 03-04-2020 read with Notification issued by the General Administration Department, Government of Jammu and Kashmir vide S.O. 166 dated 18-05-2020.
- (ii) The candidate must possess Domicile Certificate issued by the Competent Authority on the format prescribed for the purpose, on or before the last date of submission of online application form.

**(III) Reservation**

- i) Reservation for the posts shall be applicable as per Jammu and Kashmir Reservation Rules-2005 read with S.O. 127 issued by Social Welfare Department, Union Territory of J&K.
- ii) Candidates are cautioned to note that in case a claim for reservation is made on the basis of false/fake/fraudulent certificate, he/she shall be debarred from the examination(s) conducted by the University, in addition to any other action as may be deemed appropriate.
- iii) A candidate seeking his/her consideration under Reserved Categories must ensure that he/she possess a valid Category Certificate as on or before the cutoff date of the submission of online application forms. Category certificates issued after the cutoff date shall in no case be entertained.

**(5) Important Instructions to the candidates**

- The application will be accepted in the prescribed format in online mode through the University website [www.skuast.org](http://www.skuast.org). No other means/mode of application will be accepted.
- The last date for receipt of application form as stipulated above, shall be cut off date for determining the eligibility for the post. Any qualification/experience acquired thereafter shall not be considered thereafter.
- Applications received without the prescribed fee shall not be considered and summarily rejected. No representation against such rejection will be entertained. Fee once paid shall not be refunded under any circumstances nor will it be adjusted against any other examination or selection.
- The selection to the above said advertised posts shall be based only on the written test basis. Wherever, Skill Test is prescribed for post, it will be only of qualifying nature.

- The syllabus of written test/Selection criteria shall be notified separately and shall be made available on the University Website: [www.skuast.org](http://www.skuast.org).
- The applicants shall carefully fill the details in the online application forms and the information/details so submitted shall be treated as final for the purpose of determining eligibility of the candidate and no claim, whatsoever on this account shall be entertained subsequently. The candidates are advised to go through the requirements of educational qualification, age, etc. and satisfy themselves that they are eligible for the post(s).
- Only relevant qualification(s) including category status should be recorded in the Application Form, which shall be in possession of the candidate on or before the last date of receipt of the Application Form.
- The original certificates and testimonials in possession of the candidate on or before the last date of receipt of Application Form(s) together with print out copy of application form submitted online shall be required to be produced by the applicants at the time of verification of documents, as and when notified by the University.
- In case of candidates claiming possession of equivalent educational qualification (where it is applicable/required), it shall be mandatory to produce relevant Equivalence Certificate from the designated competent authorities at the time of the Document Verification. However, final decision regarding selection of such candidates will be taken by the University, in light of the relevant rules which shall be binding.
- The degree/diploma obtained through distance mode which are in consonance with the Govt. Order No. 252-HE of 2012 dated. 30.05.2012 shall be entertained, subject to fulfilment of other terms and conditions.
- Degree/diploma obtained from the Universities/Institutes declared fake by the University Grant Commission or any other regulating agency shall not be entertained.
- Canvassing by any candidate in any form will render him/her disqualified for the post.
- The candidates may note that their candidature shall remain provisional until the genuineness of their qualification/category certificate(s) is/are verified by the University.
- The number of post(s) indicated here-in-above is/are tentative and subject to increase or decrease at the sole discretion of the University at the time of appointment.
- The University reserves the right to withdraw or defer filling up of any or all post(s) advertised here-in-above at any stage without assigning any reason(s) thereof.
- The in-service candidates shall be required to submit the application form through proper channel which should reach the office of Registrar, Sher-e-Kashmir University of Agricultural Sciences and Technology of Jammu, Chatha, Jammu (J&K)-180009 within 30 days after the last date of the submission of online application form. **However, advance copy may be submitted through online mode by/or before the last date prescribed in the advertisement.**
