Sub:- 2nd Provisional Selection list of Peon, Orderly, Chowkidar, Laboratory Attendant, Library Attendant, OCC, Mali, Gardner & equivalents, following creation of the 04 vacancies after non-joining by the candidates recommended in 1st Selection List notified vide no. 76 (Secy.) of 2024 dated 24.01.2024

WHEREAS, University, vide Notification No's. 10 (Secy.) of 2022 dated 20.07.2022, advertised 50 (fifty) posts of Peon, Orderly, Chowkidar, Laboratory Attendant, Library Attendant, OCC, Mali, Gardner & equivalents, respectively, as per the following category wise break up:

WHEREAS, University, conducted OMR based Objective type written Test Examination of all the applicants of aforesaid positions on 04.12.2022.

WHEREAS, on the basis of performance of the candidates in OMR based Objective type Written Test Examination conducted on 04.12.2022, coupled with the additional weightage points awarded to the candidates by the designated committee, the result of the candidates was declared vide no. AUJ/Secy./23-24/SLF-14/1815-1817 dated 17.10.2023.

WHEREAS, declaration of the result was followed by the Document Verification (DV) of the candidates falling under consideration zone (1:2) in respective categories, by Selection-cum-Document Verification committees constituted for the purpose.

WHEREAS, on the recommendations of the Selection-cum-Document verification committee, University vide notification no. 17 (Secy.) of 2024 dated. 09.01.2024 issued the category wise provisional Selection list of candidates for the aforestated 50 post(s) of (i) Peon, Orderly, Chowkidar, Laboratory Attendant, Library Attendant, OCC, Mali, Gardner & equivalents.

Whereas, University, vide U.O. No. 76 (Secy.) of 2024 dated 24.01.2024 notified the category wise final Selection list for the 50 posts of i) Peon, Orderly, Chowkidar, Laboratory Attendant, Library Attendant, OCC, Mali, Gardner & equivalents. However the post at S.No. 49 (under SC caregory) of the Final Selection list has been kept withheld for certain clarifications from the concerned quarters.

 Whereas, in the above notification, the selected candidates were also informed to submit their verification rolls for the verification of their character antecedents from the concerned agency.

Whereas, the candidates mentioned at S.No 18 & 24 (namely by Sh. Lovish Malpotra and Nitin Sharma) under open category in the final selection list for the posts of Peon, Orderly, Chowkidar, Laboratory Attendant, Library Attendant, OCC, Mali, Gardner & equivalents did not submit their V-Rolls within stipulated period or thereafter, as such, forfeiting their claim for appointment in the University. This lead to the creation of 02 (vacancies).

Whereas, 02 (two) more selected candidates namely S. Surjeet Singh (S.No. 4) and Sh. Mukesh Rana (S.No. 26) under open category did not join this University after issuance of formal appointment order in their favour, as such their appointment in the University stands cancelled abinitio, as per the following clause of the appointment order:

"(i) an appointee shall submit his/her joining report physically in the office of Registrar, SKUAST-Jammu within a period of 21 days from the issuance of his/her appointment order, failing which the appointment shall be cancelled abinitio without any further notice".

Consequently upon the arising of 04 vacancies after non-joining by the candidates recommended in the 1st Selection List, the 2sd provisional selection list of additional 04 (four) candidates falling next in merit under open category and whose documents have already been verified by the Selection-cum-Document verification committee in the 1st Phase, is hereby notified as per Annexure-I. It is further notified that:

- The provisional Selection list shall be subject to the outcome of the writ petition (s)/application(s), if any, pending adjudication before any competent court of law.
- The provisional Selection list shall also be subject to the outcome of any pending enquiry, if any, involving candidate(s), figuring in the Selection List.
- This is a provisional list only and shall be subject to change as per the objections as may be received against it and it shall not confer any right for final selection, which shall be notified after taking note of the objections based on merit.
- 4. Further, the University also reserves the right to make any corrections changes in the Selection List at any later date as may be found necessary Suo motto or on the request of the candidate(s) on the basis of documentary evidence, if any.
