The engagement shall be governed by the following terms and conditions:-

- The engagement shall purely be temporary, time bound; non-regular on academic arrangement basis and the contractual appointee shall not be entitled to any claim of absorption/regular appointment in the University/continuation of service beyond the time stipulated herein.
- The engagement shall initially be for one academic semester extendable for one more (next semester) on the basis of performance during Academic Session 2024-25 depending upon satisfactory work and conduct performance of the appointee as well as the availability of the funds.
- The appointee before joining shall have to execute an legal agreement with the Dean FoH&F, SKUAST Jammu Chatha (a constituent of the university) on the prescribed format appended duly attested by the First Class Magistrate.
- The engagement of appointee shall be terminable before the expiry of the specified period with one month's salary in lieu of notice by the appointing authority/or the engaged teacher, as the case may be.
- The work and conduct of the appointee shall be monitored, if found unsatisfactory, the service will be terminated without any notice.
- The appointee shall have to report within 21 days from the issue of the order to Prof. & Head, Division of Statistics & Computer Science, FBSc failing which the appointment shall be treated as cancelled automatically.
